Sir,

In producing herewith one lady accused person namely Kabita Gurung @ Lalita Gurung D/o Lt Anand Gurung of Sahidnagar Near Hindi School, PS Bhaktinagar Dist Jalpaiguri along with the following seized articles as per proper seizure list:

1. 30 (Thirty) no's of pet Bottles of Himalayan Gold 60up country sprit (each bottle containing 600ML in each bottle mentioning M.R.P of Rs- 100/- in each bottle i.e. total amount of Rs- 3000/- (Three thousand only) All the articles packed in Two big nylon bag.

I beg to report that I, ASI Biplob Das of Bhaktinagar PS under Siliguri Police Commissionerate lodged a written complainant against one Kabita Gurung @ Lalita Gurung D/o Lt Anand Gurung of Sahidnagar Near Hindi School, PS Bhaktinagar Dist Jalpaiguri to the effect that on 14.08.21 at 13.45 hrs received a source information from Check post Try junction under Bhaktinagar PS that one lady was standing at that place with huge quantity of liquor for selling the same in the open market for her wrongful gain without any documents/license. Diarized the fact in GD vide Bhaktinagar PS GDE No-802 dated 14.08.21. As per your kind instruction myself along with Lady Police personal and force proceeded to the PO to work out the information. At 14.10 hrs we reached at the spot, sometimes after, being identified by the source our police party held raid and recovered the above noted articles from her possession. During local enquiry it came to learn that she is selling the same in open market since long for her wrongful gain without any valid documents/license. In presence of witnesses I seized the above noted articles from her possession after prepared proper seizure list and arrested her after maintain all formalities in presence of lady police personal. (The seizure was made in between 14.25hrs to 15.20 hrs)

I therefore request you a specific case may kindly be started against the accused person namely Kabita Gurung @ Lalita Gurung D/o Lt Anand Gurung of Sahidnagar Near Hindi School, PS Bhaktinagar Dist Jalpaiguri under proper section of law and arrange for investigation..
