Police Station, Siliguri Police Commissionerate after producing the accused person namely Ranjit Mahato-35yrs s/o Deb Narayan Sub-Inspector Srimanta Chatterjee of Bhaktinagar Sir, Mahato of Champasari, Anchal, Ward No-46 of SMC, PS Pradhannagar Dist Darjeeling and seized total 100 (Hundred) bottles of Altorex-CD cough syrup contained in a one big plastic sack and one Honda Activa Scooty bearing No-WB74AS/9298, do hereby lodged written complaint to the effect that on 16.08.21 at 21.25 hrs received reliable source information that one person was standing in front of Reliance Market, Sevoke road, Salugara through a Scooty loaded one big plastic sack in his vehicle contained illegal drugs (Cough syrup) to deliver the same to someone. It is reasonably believe that the person possessing the bags containing cough syrup may escape from the scene if Police party did not reach the spot immediately. The information was reduced in writing vide Bhaktinagar Police Station GDE no. 908 dated 16.08.21 and informed superiors about the plan of action. Thereafter myself along with ASI Rabin Lama, ASI Bipliab Das, C/374 Debraj Biswas, CVF/935 Bipliab Roy and CVF/619 Dharmendra Roy taking blank paper, wax, metal seal and knife and other kits left for Sevoke road near Reliance Market to work out the information vide Bhaktinagar PS GDE no-909 dated 16.08.21 & MCC No- 243/21 dated 16.08.21..

At 21.42 hours I along with officer and force reached near Reliance Market, Sevoke road and contacted the source who show us the person with the big plastic sack with one Scooty suspected to be contained Cough syrup from a certain distance, I briefed all Officers and force to cordon the person as tactful as possible in order to thwart his escape from the scene. Meanwhile I called two local and independent witnesses namely 1) Abhijit Sutradhar s/o Dhiren Sutradhar of Pareshnager, behind Payel Cinema Hall, ward no-44 PO Salugara PS Bhaktinagar Dist Jalpaiguri (2) Dipak Biswas s/o Lt Gopal Biswas of Prakashnagar PO Salugara PS Bhaktinagar Dist Jalpaiguri and after apprising them about the information received requested them to remain present with us during search and seizure. We rounded him up and questioned about his name and address when he disclosed his identity as above. On interrogation about the bag possessing by him, initially did not disclose anything about contains of bag. I forced him to open it, when he disclosed that the bag contain cough syrup belongs to him. On further interrogation he disclosed that he procured the illegal cough syrup from Champasari side to deliver the same to another person. Then I detained him and gave an option in writing whether he is willing to be searched in presence of an Executive Magistrate or Gazette Police Officer, on return he given written reply that he is willing to be searched in presence of Gazette Police Officer. Then I informed Shri Amresh Singh, Inspector In-Charge, Bhaktinagar Police Station to come to Sevoke road near Reliance Market requested him to presence during search and seizure of the cough syrup.

Qualinante dellerge

At 22.40 hrs Shri Amaresh Singh, Inspector In-Charge, Bhaktinag: Pouce Station arrived at spot. Thereafter I opened the bag and found total 100 (Hundred) bottles of Altorex-CD anti allergic chlorpheniramine Maleate & Codeine phosphate cough syrup inside. I asked the accused person above named to produce document if any in support of possessing such a huge quantity of cough syrup with them but he is failed to produce and document. I seized the following articles under proper seizure list in presence of witness under direct supervision of IC Bhaktinagar PS under proper labeling. I informed Drug Controller Jalpaiguri over telephone requesting him to remain present at the spot but due to late night he failed to appear the PO.

NATURE OF ARTICLES SEIZED

- 1) 100 (Hundred) bottles of Altorex-CD anti allergic chlorpheniramine Maleate & Codeine phosphate cough syrup each bottle containing 100 ML in which chlorpheniramine Maleate 4 mg & Codeine phosphate 1P 10mg each Manufactured by Alto Health care Pvt Ltd, B-5, Sector-5, Bawana, Delhi-110039 marked as Exhibit-A out of 03 bottles taken as sample marked as

 - 2) One Black colour Honda Activa Scooty bearing No-WB74AS/9298 3) One black colour Samsung mobile phone vide IMEI No- 354739892496295 with Airtel sim (Phone No-8159861322)

(Seizure was made in between on 16.08.21 in between 23.15 hrs to 23.50 hrs)

Under the above circumstances it is evident that the accused person above named procured has committing offence under NDPS act. On interrogation accused confessed his guilt and stated the he is doing such kind of business illegally with any valid documents/License since long for his wrongf gain. It is crystal clear that the accused is the king pin of the racket who has been peddliprescription drugs meant for the sick people to cater to the need of drugs abusers in the local illegally which has become menace to the life of the young generation and perishing the home thousand parents. All the seized contents Psychotropic substance and falls under NDPS act. arrested him u/s 41 Cr.P.C. after explaining them about the ground of arrest issuing proper meme arrest. Arrested accused person Ranjit Mahato along with seized articles brought to PS, seizure and seized articles handed over to Malkhana dealing Officer under intimation to I.C. PS for keep record in PS property register.

I therefore pray that a specific case u/s Narcotic Drugs and Psychotropic Substances Act may kindly be started against the accused person namely Ranjit Mahato-35yrs s/o Deb Nar Mahato of Champasari, Anchal, Ward No-46 of SMC, PS Pradhannagar Dist Darjeeling and arrang Ja Virgont o State its investigation.
