I, SI Uttam Kumar Ghosh of Siliguri P.S./ SPC, do hereby lodge complaint against the above noted 35 arrested persons, to the effect that, On 17.08.2021 at about 07.45 hrs while I was performing van duty received a telephonic information from duty officer that some leaders and supporters of Bharatiya Janata yuba Morcha were gathering to organized of "Yuva Sankalpa Yatra" at Venus More, Siliguri. Accordingly I along with forces had been to the spot to work out of such information. On arrival I found that the above persons of BJYM leaders and members was gathering to organized of "Yuva Sankalpa Yatra" without getting any valid permission from the local Police authority or Civil administration and without maintaining social distancing and also without wearing mask on their face violating the order for combating the spread of COVID-19 as per order of Govt. of India duly promulgated in order No. 753/III-ISS/2M-22/2020 Govt. of West Bengal Ministry of Home affairs dated 14.07.2021. Accordingly, I along with other officers and forces tried to despatch their gathering from Venus more area but they did not pay any heed and suddenly started scuffling with us, in order to dismantle the police barricade. Subsequently being obstructed at Venus More, they started sit & demonstration at Venus More. Finding no alternative we arrested the above noted persons.

Now, I request you for starting a specific case U/S- 188/269/270 IPC R/W Sec. 51(b) Disaster Management Act, 2005 against the above noted thirty five (35) arrested accused persons and also request you for arranged proper investigation of the case.
