Respected Madam,

I Smt. Suchitra Das, w/o. Ranjit Das, resident of Hemanta Basu Colony, Near Vivekananda School, P.O. & P.S. Siliguri, Dist.- Darjeeling, would like to draw your kind attention, that I have been married with Sri. Ranjit Das since 15 years and out of the said wedlock we have a girl child namely Miss. Harsha Das who is now 13<sup>th</sup> years old.

That since the said marriage I have been staying in my matrimonial house along with my husband ( Ranjit Das), my Father-in-law namely Bikhari Das, Mother-in-law namely Shankari Das, Brother-in-law namely Sanjit Das, Sister-in-law namely Nilam Das w/o. Sanjit Das.

That since my marriage the in-laws regularly torturing me both physically and mentally and this torture is increasing day by day. That on 31.03.2021 I lodged one F.I.R. regarding the said matter and a specific case was started against my in laws being Siliguri Women P.S. Case no. 43/2021, Under Section 498A, 506, 109 of I.P.C.

That my in-laws in collusion with their relatives and my brother-in-law in relation namely Naveen Das s/o. Tuntun Das of Village Bagha Chowk, P.O. Nagdah, Begusarai, Pin.- 851117, Bihar, and Mr. Om Prakash Das, son of Late Ram Prakash Das of Village Musapur, P.O. Bahadurpur, P.S. Ghathao, Dist.- Samastipur, Pin.- 848114, Bihar, are trying to evict me from my matrimonial house. All of the above named persons are making conspiracy to throw me out of my husband house and their forcing my husband to marry some other girl of Bihar.

That there was a dispute between me and my husband as my in-laws always injected my husband mind with negative talks and tried to break our relation but now my relation with my husband is good and we are leading happy marital life which is intolerable by my in laws.
