I, SI Sumit Sarkar of Pradhan Nagar Police Station under Siliguri Police Commissionerate do here by lodge this written complaint to the effect that today i.e 17.08.2021 in between 14.45 hrs. to 15.45 hrs myself along with force of Pradhannagar Police Station had been to Champasari More area, PS-Pradhan nagar, Darjeeling for Spl van duty and found the above noted persons were loitering without mask and violating the other norms of Govt. order .On being asked the above noted persons stated before me that they had well to aware of the pandemic situation. Hence, they violated the order for combating the spread of COVID- 19 as per order of Govt. of West- Bengal vide order No 647-ISS/2M-22/2020 dated 15.05.2021 and Notification number 347 -01.S.S / 2M-24/2020 dated 3rd June,2020 and Memo No 486-CS/2021 dated 24th April , 2021 in view of break-out of pandemic COVID-19 throughout the country as well as State.

Accordingly, I arrested them u/s 41 CR.P.C in c/w the above case. Hence, I request you for starting a specific case u/s 188/269 IPC R/W Sec 51 (b) Disaster Management Act, 2005 against the above noted arrested persons and arranged to proper investigation of the case.
