Respected Sir/Madam,

That this is to inform you and your concerned office that I, Sri Drabir Sarkar, Resident of Adarsha Nagar colony, Ward no-4, Mahananda Para, Siliguri, a Senior citizen in the State of West Bengal. I had been sending lottery tickets worth about Rs. 50,000 to my son named Sri Sharique Sarkar as Raw materials for our Lottery Business who has a shop in Kurseong, Under the supervision of a driver named Sri Amir Darnal, Son of C.B. Darnal having his residence at Rohini, Kurseong having a mobile number of "7432821393" and he runs the vehicle, bearing the number - **WB-76-6989**.

That since it was very urgent to send the Consignment, we had no other options, therefore opted to send it with the Driver of the vehicle. with whom we had a fiduciary relationship. The vehicle had its syndicate address at Gurang basti more, Hill Cart Road Opposite Rajdarbar Hotel, but after some time it was informed to us round 9.30 A.M. that our consignment has gone missing from the vehicle while he went to have his lunch leaving the consignment unattended but we strongly believe that its entirely the conspiracy of the Driver for selling the lottery tickets and thereby earning profits.

That therefore due to this reason I have been suffering mentally due to this loss that we are suffering hence I request you to take necessary actions for reviving back the consignment and to record the above intimation letter in your respected books so that there may be no obstruction to justice, peace and book the miscreants under the law of the Land.
