Sir,

With due respect I PSI Youel Lepcha do hereby lodge this written complaint to the effect on 18.08.2021 at around 13.30 hrs in course of my patrolling van duty I received an information of accident at Old Pradhan Nagar PS More under Pradhan nagar PS from duty officer. Accordingly myself along with force had been to old PS more and found that the accident occurred between Bus having registration No. WB 76A 8265 and a ToTo having Reg. WB 73F 5046. As a result passenger of the ToTo got injured and the ToTo has also been got damaged. Injured persons were shifted to Siliguri District Hospital for their treatment. The driver of the offending bus fled away from the place leaving behind the bus.

On further Enquiry it could learnt that the right side cabin door of the Bus was opened in running condition and dashed the Toto from back side which was carrying passenger at Old Pradhan nagar PS more. Accordingly, I brought the offending bus at PS and kept it at PS compound.

I therefore request to you to kindly registered a specific case under proper section of law against the driver of the offending bus having reg. No. WB 76A 8265 and arrange for its investigation
