The names are (1) Pardeep Paswan of Litali Bagan of Bagdogra (2) Munna Mehera of Bhujipani Bagdogra, they were outside junglee baba mandir when I was crossing by that boys they used very abusive and filthy languages to me. Thereafter I stopped at that place and said to that boys why are you using this type of languages after these, they started arguing with me which converted into attack with some kind of things they also beaten on my eyes which resulted in a harmful damage to my eyeside. I have visited to Bagdogra hospital where doctor refer me to the N.B.M.C.H.

This is a humble request to take some action in this matter and please kindly take my complain.
