Sir,

In producing herewith the arrested accused person namely i) Prakash Oraon 28yrs s/o Late Matlu Oraon Vill: Tarabari PO, New Rangia PS, Bagdogra Dist, Darjeeling along with the seized (1) Vehicle No bearing registration no. WB73/1562 (Saktiman Truck) loaded with sand, I beg to submit that today on 19.08.2021 at 17.05 hrs in course of my evening special mobile van duty, vide GDE No. 1322 dtd 19.08.2021 along with ASI Asish Karmakar and force received acting a secret source information we reached at Gossainpur More and found the mentioned Vehicle was coming towards Gosainpur More from Tarabari side along the road and intercepted the same. On searching, the said vehicle was found loaded with sand. On demand, the accused person Prakash Oraon, the driver of Vehicle No. WB73/1562 (Saktiman Truck) failed to produce any valid documents or license in support of him for lifting and transportation of the same. So, there is sufficient ground to believe that the said loaded sand were taken either theft or any other fraudulent means and for which, I seized the Vehicle No. WB73/1562 (Saktiman Truck) loaded with sand under proper seizure list maintaining all formalities, the seizure process was made in between 17.20 hrs to 17.45 hrs and subsequently arrested the said accused person Prakash Oraon observing all formalities and narrated him the ground of his arrest.

During interrogation, he confessed his guilt that he was carrying the sand loaded in said Vehicle being lifted from Tarabari side for illegal gain without any valid document.

Under the above circumstances, I pray to your honour that a specific case under proper section of law, may kindly be registered against Prakash Oraon 28yrs s/o Late Matlu Oraon Vill: Tarabari PO, New Rangia PS, Bagdogra Dist, Darjeeling the driver of Vehicle No. WB73/1562 (Saktiman Truck) and arrange for its investigation.
