Currently, Mr. Nishant Jha is working with
ICICI Bank Pvt Ltd as Relationship Manager, B16
at Saharav House, Near Anandalek Hospital; Seroke
Road, Siliguri, 734001 (Ph no: +91 99312 58992).

On 22nd January, 2017 I was solemnly married to
Nishant Jha; son of Mr. Karunwant Jha;
Permanent Address, "C/O Karunwant Jha, Rakha, Near
Masjid, ward no 04, Rakha, Madhubani, Bihar, 847238.

After marriage, he used to torture and abuse me
both verbally as well as physically since long. This
is a daily affair for him. He threatens me
for my life and burning me with hot Tawa or iron.
He abuses me in the public places. He harasses
me everyday saying that I did not get anything for
my marriage (dowry). His brother, Prashant Kumar
Jha also abused me verbally multiple times.

On 14th Aug, 2021 he abused me verbally as well as
physically using slippers, belts and strangled me till
death. He strangled me with his belt and used his
other hand to press my nose with his knees over my
chest. He tried to kill me and threatens me for it
usually also.

Therefore, I kindly request strict legal action to be taken
against him and his brother.
