Respected Sir,

With due respect, I **DR. SHIB SHANKAR SASTRI**, Son of Late Bibhuti Bushwan Majumder, residing at Green Valley Apartment, Block-6C, Ground Floor, Upper Bhanunagar, P.S. Bhaktinagar, Dist. Jalpaiguri beg to state that I am a 70 Years old Senior Citizen and residing in the aforesaid flat alone and recently I have constructed a Radha Krishna Temple inside my aforesaid flat.

In the month of December 2020, due to need of some idols and panels in my aforesaid temple, I was in search of an Artist and at the relevant time, one of my family friend informed me that she found one Artist from Krishnanagar and I have requested said family friend to meet with the Artist on my behalf and to give them my contact details to him. Thereafter in the middle of December 2020, one person namely Samiran Bag from Ghurni (Shibtala), P.O. Ghurni, Krishnanagar, Dist. Nadia called me over telephone and after taking my address, on 15/12/2020, said Artist namely Samiran Bag along with his wife came to my Flat situated at Green Valley, Siliguri and he has given me a quotation for idols and panels mentioned in his quotation dated 15/12/2020 and quotes an amount of Rs.10,00,000/- for all the panels and idols including carrying and fixing costs. On the same day, in my flat, I have paid a sum of Rs.10,000/- in cash and Rs.2,40,000/- through bank transfer to said Samiran Bag. I had also given a post dated cheque amounting of Rs.50,000/- vide cheque no. 821669 dt. 04/02/2021 to said Samiran Bag which was encashed by him. Thereafter, on 21/03/2021, I have deposited Rs.25,000/- in his bank account.

Artist Samiran Bag had also assured me in his written quotation that he will all the idols and panels to my flat at Green Valley within 4(four) months within the month of April 2021, but even after expiry of four months, he neglected to handover the idols and panels to me and used to demand more amount from me. Due to his delay, I could not open my temple in due time. Thereafter on 21/06/2021, said Samiran Bag sent a letter through whatsapp to me and himself cancelled the order of two life size silicon fitting idols amounting of Rs.2,00,000/- (Two Lakhs) without my consent, and told that he could not make such idols. I would like to mention that said life idols was my main requirement, otherwise I would order other panels from Siliguri/Matigara.

In such letter dated 21/06/2021, Samiran Bag has declared that he has received Rs.3,25,000/- and when I will give him further amount of Rs.20,000/-, he will do the work within 15 days. Finding no other alternative, I have again deposited a sum of Rs.20,000/- on 22/06/2021.

Lastly on 08/07/2021, he has come to my flat with some labours and received further amount of Rs.20,000/- from me and thereafter, till 11/07/2021, Samiran Bag along with his labours worked in my flat and on the last day, he has again received a sum of Rs.10,000/- in cash and the DD of Rs.1,75,000/- dt. 07/07/2021 from me. On 11/07/2021, I have noticed that Artist Samiran Bag has installed plywood frame instead of Glass Fiber Frame in the panels and maximum panels of Gods are broken condition. When I have raised objection, he has told me that he has done the work only for opening ceremony of my temple and he has assured me that within 2-3 days he will replace the said panels. Samiran Bag has also told me that due to his material shortage, he could not fix/install good quality frame and he has assured that after 2/3 days, he will replace all the frames, broken panels etc. He has also assured me that he will not claim further amount from me. But on 12/07/2021, he along with his labours fled away.

That thereafter, on several occasions and till this day, I have requested said Samiran Bag to come to my flat and to replace the frames and to fix the good idols and panels by removing the broken items, but in all times, he has been neglecting and refusing to come to my flat and to replace the same.

At the time of placing my order and at the time of giving me quotation i.e. since the very beginning with an intention to cheat me, said Samiran Bag has dishonestly fraudulently induced me to pay a sum of **Rs.5,50,000/-** to him and finally he has fixed and installed broken panels of Gods, has not given silicon fitting life Idols as per his quotation, has also fixed plywood frames instead of glass fiber and thereby committed breach of trust.

Therefore, I request you to take necessary legal action against the above-named Artist namely Samiran Bag, situated at Ghurni (Shibtala), P.O. Ghurni, Krishnanagar, Dist. Nadia. And for this kindness, I shall much oblige to you.
