Dear Sir,

With respect this is informed you that I, Smt Jayanti Roy , Age about 30 years, wife of Sri. Dipak Singh (Mob No. 7679369498); Daughter of Sri. Kali Charan Roy , resident of Chayanpara, Roy Colony More, Swagat residency , Flat No.205, P.S. Bhaktinagar, Dist.Jalpaiguri, at present I residing at Natunpara , Ward V S.M.C. got marriage with Sri. Dipak Singh ,on dated 14/05/2021.After the Marriage I was tortured by my husband and his sister Rupa Karmakar(Mob No.9064012363), and mother , Shanti Singh, they tried to kill me several times. They are beating me till I am senseless . They did not allow me to get outside or my Father's home at Natunpara, Siliguri. They are behaving like a animal. They beat me and does not let me sleep. When they start to beat me, they torture me whole night . When they are outside the Home, they lock me inside the home. They also did not allow me to make any phonecall to my father or brother or anyone. On dated 16/08/2021 at about 9:30 P.M. , they have physically assaulted me, they gripped my neck with their strong hand and at that time I felt Suffocated, They have beaten me badly and I had a serious sign of being beaten Left Hand at present . My father is in serious position and call my another sister and told all my miserable condition , thereafter my sister came to my house on dated 17/08/2021 at about 12:00 noon, after several requests by her and they have taken confirm guarantee that Jayanti Roy will be returning back to me in the evening. Thereafter they allowed me to go back my Father's home. They are still threatening on telephone. I am in fear and my life is in danger. Please take immediate action against my husband and his family member. I herewith enclose a Hospital report of dated 17/08/2021 to you.
