Sir,

In producing herewith one accused person namely Adip Pradhan-37yrs s/o Tek Bahadur Pradhan of Singbuli tea Estate PO Phuguri PS Mirik, Dist Darjeeling at present Sevoke road, near Marowari Bhawan PS Bhaktinagar Dist Jalpaiguri along with the following seized articles as per proper seizure list:

1. 26 (Twenty six) no's of pet Bottles of Himalayan Gold 60up country sprit (each bottle containing 600ML in each bottle mentioning M.R.P of Rs- 100/-in each bottle i.e. total amount of Rs- 2600/- (two thousand six hundred only) All the articles packed in one big nylon bag.

I beg to report that I, SI Srimanta Chatterjee of Bhaktinagar PS under Siliguri Police Commissionerate lodged a written complainant against one Adip Pradhan-37yrs s/o Tek Bahadur Pradhan of Singbuli tea Estate PO Phuguri PS Mirik, Dist Darjeeling at present Sevoke road, near Marowari Bhawan PS Bhaktinagar Dist Jalpaiguri to the effect that on 20.08.21 at 14.40 hrs received a source information from Sevoke road near Uttar Baga Marowari Bhawan under Bhaktinagar PS that one person namely Adip Pradhan has gathered huge quantity of liquor in his street shop cum house style as Pradhan Tea Stall for selling the same in the open market for his wrongful gain without any documents/license. Diarized the fact in GD vide Bhaktinagar PS GDE No-1121 dated 20.08.21. As per your kind instruction myself along with force proceeded to the PO to work out the information. At 15.10 hrs we reached at the spot, sometimes after, being identified by the source our police party held raid and recovered the above noted articles from his possession. During local enquiry it came to learn that he is selling the same in open market since long for his wrongful gain without any valid documents/license. In presence of witnesses I seized the above noted articles from his possession after prepared proper seizure list and arrested him after maintain all formalities. (The seizure was made in between 15.15hrs to 15.50)

I therefore request you a specific case may kindly be started against the accused person namely Adip Pradhan-37yrs s/o Tek Bahadur Pradhan of Singbuli tea Estate PO Phuguri PS Mirik, Dist Darjeeling at present Sevoke road, near Marowari Bhawan PS Bhaktinagar Dist Jalpaiguri under proper section of law and arrange for investigation..
