Sir,

In producing herewith one accused person namely Sujan Bapari (23) S/O Ranjit Bapari Of Shantinagar Boubazar Pipeline PS Bhaktinagar Dist Jalpaiguri and the following articles under seizure

- (1) 14(Forteen) bottles of "HIMALAYAN GOLD PREMIUM 60 UP COUNTRY SPIRIT" each bottle containing 600 ML, MRP Rs.100/- (Total- 8.4 Liter & Amount Rs 1400/-).
- (2) 15(Fifteen) bottles of "SEAGRAMS ROYAL STAG DELUXE WHISKY " each bottle containing 180 ML, MRP Rs.70/- (Total-2.7 Litre & Amount Rs. 1050/-)
- (3) 05(Five) bottles of "HAYWARDS 5000 SUPER STRONG BEER" each bottle containing 650 ML,MRP Rs.130.(Total 3.25 Litre & Amount Rs.650/-)
- (4) 04(Four) bottles of " MCDOWELLS NO -1 SUPERIOR WHISKY ORIGINAL " each bottle containing 180 ML,MRP Rs. 174/-(Total .720 Litre & Amount Rs. 696/-)

I SI Pradip Kr Singha of Ashighar OP lodged a written complaint against the accused person namely Sujan Bapari (23) S/O Ranjit Bapari Of Shantinagar Boubazar Pipeline PS Bhaktinagar Dist Jalpaiguri to the effect that, on 20.08.2021 evening as per order of O/C Ashighar OP I along with ASI Sumit Baran Nath, C -729 Dinesh Ch Roy and C/1013 Sanjau Singha , all of Ashighar OP with Govt. vehicle no WB42/R 8829 were holding raid against anti social elements, warrentees, ID liquor etc in different area under Ashighar OP in c/w Muharram as per order vide Ashighar OP GDE no. 517 Dt 20.08.2021 in course of which I received information from my source that one Sujan Bapari stored a huge numbers of bottles liquor inside his Fish Shop at Shantinagar Boubazar Pipeline and used to sell to the local youth in higher rates. I immediately informed O/C Ashighar OP and as per his kind direction wasting no time I along with my accompanied party left for Shantinagar Boubazar Pipeline area to verify the veracity of information. On the way I called two local person namely (1) Dilip Ghosh (37) S/O Kali Charan Ghosh of Ghugumali PS Bhaktinagar Dist Jalpaiguri and (2) Ajay Sarkar (31) S/O Sunil Sarkar of Niranjana Nagar W/no.36 PS Bhaktinagar Dist. Jalpaiguri to accompany us to witness the search and seizure if required. On reaching at Shantinagar Boubazar Pipeline area as indicated by my source I held raid at the Fish Shop of Sujan Bapari at Shantinagar Boubazar Pipeline . But seeing us the above noted accused person tried to flee away from the spot, but we managed to apprehend him. I searched in the Fish Shop at Shantinagar Boubazar Pipeline of above noted accused person, in course of which I recovered the above noted bottles of liquor from inside his Fish shop. I seized the above noted articles as alammath of the case, as the above noted person as well as none could be able to produce any documents for such illegal possession of such articles. I also arrest the above noted accused person for violating the provision of B.E Act. The Search and seizure and arrest were made in between 21.10 hrs to 21.35 hrs on 20.08.2021.

Under the above circumstances, I pray to you that a specific case may kindly be started against the accused person Sujan Bapari (23) S/O Ranjit Bapari Of Shantinagar Boubazar Pipeline PS Bhaktinagar Dist Jalpaiguri and arrange for its investigation.
