Sir,

I, Dr. Durlav Roy, S/o. Dr. Dipak Kumar Roy, resident of 42/1, j.c. Bose Road, Hakimpura, Siliguri, District-Darjeeling, would like to inform you that the incident took place when I was returning from my hospital (i.e., Bidhannagar PHC) at around 3.00 p.m.-afternoon on 17/8/2021 i.e., yesterday at Hasmi chowk, Siliguri as soon as the green lights were switched on, a Maruti Alto Car (Cherry red Colour) dashed against my car from backside and damaged /broke my car's a. Right sided rear light b. Rear Bumper and c. Rear guard. Immediately heated altercations took place, the driver of the car started abusing me and also physically assaulted me, insulted me by hurling various slangs and filthy languages as soon as I asked him to pay me monetary compensation/damage charges.

Mr. Sachindra Roy, as told by him, was in a drunken/intoxicated state, he was recklessly driving and also did not maintain the minimum distance that should be maintained in between two cars.

As the accident took place in presence of traffic police, civic- volunteers and many by standers. In presence of traffic police, after a mutual understanding he agreed to pay for the repairing my damages.

However, he said that right now he will not give any monetary compensation but he shall accompany me to a car repairing garage and bear the cost of repairing.

After reaching the car repairing garage he completely refused to pay me any damage charges.

After which I have decided to appeal for justice in the court of law.

I have also learned after searching for his car through a RTO app in my mobile phone that he has failed to pay for his insurance policy last year and has not renewed his insurance policy since then.

He has been violating the law by driving the car without insurance policy from last one year.

I would be highly obliged if you kindly investigate in this matter as early as possible and register a case/lodge an F.I.R. and take necessary legal actions.
