Sir,

In producing herewith arrested female accused person named Karuna Mangar (38), W/O - Himu Mangar of - Durga Mandir, Kadamtala, PS - Matigara, Dist - Darjeeling along with copy of memo of arrest and seized articles viz 15 (fifteen) bottles of Sealed Himalayan Gold Bottles 60Up Country Spirit each containing 600 Ml Rs. 100/- each totaling amount of Rs 1500/- with proper lady police escort.

Today i.e 21.08.2021 at 13.50 hrs I, ASI Dulal Dey of NBMC OP along with C/131 Kanuram Sarkar, CV/ 920 Kamal Barman and LCV 497 Priyanka Singha while conducting special raid against anti social elements, warrantees, ID liquor etc in vehicle no WB74/8035 at different area under NBMC OP in course of which I received an information from source that one female person is selling Liquor illegally in huge quantity in a clandestine way at road side petty shop at Durgamandir, Kadamtala under Matigara PS. As soon as after receiving information I informed the matter to O/C NBMC OP and as per his order and instruction I along with force conducted raid in the petty shop of Karuna Mangar. During raid I found one Karuna Mangar is 15 (fifteen) bottles of Sealed Himalayan Gold Bottles 60Up Country Spirit each containing 600 Ml Rs. 100/- each totaling amount of Rs 1500/- hidden inside her shop and selling it to the customers in concealed manner. Accordingly, I seized the above noted articles in presence of police witnesses and lady police personnel, I demanded papers and license / cash memo of those seized articles but she failed to produce any documents in support of her possession of above noted illicit liquor. On interrogation, she disclosed her name as mentioned above and admitted that she procured the liquor illegally and had been selling the same illegally to the people. I, accordingly, seized those illicit liquors U/S 102 CrPC in presence of witnesses after preparing proper seizure list duly signed by the witnesses as well as the accused and also labeled the same. Then, I arrested her U/S 41 CrPC with help of lady police with keeping in mind modesty and proper health measures. The search, seizure and label were made from 14.10 hrs to 14.35 hrs. Then we left the place with the arrested person and the seized articles.

Under the above circumstances I pray before your kind self that a specific case under proper section of law may kindly be initiated against the female accused person named Karuna Mangar (38), W/O - Himu Mangar of - Durga Mandir, Kadamtala, PS - Matigara, Dit - Darjeeling and kindly arranged for its investigation.
