District of Jalpaiguri, would like to lodge a written complaint against the above named
ADVOCATE AJAY SINGHAL and others stating as follows:

1. That I am one of the employee of one Smt Chameli Devi W/o Sri Devi Ram Agarwal
who is aged about 84 years and I am looking after her property at Chhobavita, Near
Cannel Road, Fulbari, P.S. NJP in the District of Jalpaiguri.

2. That today at around 5.00 pm, when I was in the premise, one person by the name
ADVOCATE AJAY SINGHAL along with three other approached our premise. Mr
Ajay Singhal was in Black Coat and they tried to enter the premises, he claiming
himself to be "officer of court" started threatening us and directed me to vacate the
premise and when I asked him to show on what basis and by what authority he
had come there, he along with his associates become annoyed and infuriated and tried
to hit me with a blow. I immediately started to make a video of him and his associates
(CD enclosed), (wherein he is clearly depicted in claiming himself to be officer of
court).

It is pertinent to mention here that if he had any authority and/or any order to make
himself available at the premises he should have come through proper channel but
neither he had shown any authority nor any order but had only acted illegally.

3. That seeing me make their video the above named ADVOCATE AJAY SINGHAL
and his associates snatched my mobile phone and threw it and a verbal argument
started between us but all of a sudden the said advocate hit hard on my chest, snatched
my gold chain and wallet containing approximately Rs. 20,000/- and other important
documents in between I managed to get escape from their grip and ran outside the
premise and in order to ensure my safety locked the gate from outside. I then called
your police station and after sometime a Police van came and matter was proceeded.

4. That I then called my employer and narrated the incident and also showed the
recording. That after seeing the recording the recognized the persons to be the
employee on Sunshine Foods .

It is was informed to me by my employer that pertinent to mention here that the
license has already been cancelled and it is in my knowledge that all the belongings of
the said company has already been taken away by its employee. The people of
Sunshine Foods are since months harassing my old aged employer in order to grab the
property of my employer.

5. That from the temperament and behavior of the above name advocate, men and
associates of Sunshine Foods it is believed that they are none other but gundas and
land grabbers who are trying to grab innocent people's property.
