I, SI Hiru Kanti Sarkar of Siliguri PS, SPC do here by lodged a written complaint against above noted arrested accused person Ritu Debi Sahani (32) S/O Pradip Sahani of Tikiapara, Mazdoor Colony, Ward No. 28, PS- Siliguri, Dist-Darjeeling to the effect that on 21.08.21 at 08.05 hrs acting on secret information, I received a source information that the above noted person was busy to sale Id liquor illegally in her house situated at Tikiapara, Mazdoor Colony, Ward No. 28 under Siliguri PS in order to clandestinely dispose the same. Accordingly the fact is diarized in GD vide Siliguri PS GDE no. 1264 dated 21.08.21 and informed the fact to I/C Siliguri PS. As per direction of I/C Siliguri PS, Lalong with PSI Rajiv Subba, LCV/176 Parbati Barman, CV/283 Prosenjit Dey left for Tikiapara, Mazdoor Colony, Ward No. 28 under Siliguri PS to verify the veracity of the information vide Siliguri PS GDE No. 1265 dated 21.08.21. On reaching at 08.25 hrs there and as identified by source cordoned the above noted area where she was selling illegal alcohol. On seeing the police party the above noted person tried to escape from the spot but we managed to apprehend the above noted person with the help of lady force and on interrogation, the above noted person disclosed his identity as noted above. On searching - i) 21 (Tweenty one) sealed bottles of Himalayan Gold 60 up country spirit containing 600 ml. each labeled as Himalayan Endeavour PVT. Ltd. Siliguri, West Bengal @ Rs 100 each (Amounting of 21 x Rs 100/- =RS.2100/-) which was kept concealed in her house

situated at Tikiapara, Mazdoor Colony, Ward No. 28 under Siliguri PS. On being interrogation she could not produce any valid documents in respect of the said liquor. She also stated that she is doing this liquor business since long for wrongful gain. Accordingly I seized the same in presence of witness duly signed by them. The seizure and label was made in between 08.35 hrs to 09.15 hrs. On being asked she stated that she used to sale the same to locality without any valid documents as she has violated the norms of Bengal Excise Act for selling the said seized articles without any valid license. As such I arrested her U/S-41 Cr.P.C after observing all sorts' of rules.

Therefore I pray before your honor that a specific case may kindly be started against the arrested accused person Ritu Debi Sahani (32) S/O Pradip Sahani of Tikiapara, Mazdoor Colony, Ward No. 28, PS- Siliguri, Dist- Darjeeling along with seized articles under proper section of law and arrange for its investigate.
