In producing herewith one arrested accused person namely Babul Roy (40) S/O Lt. Mahim Roy of Netajipara, near Buraburi mandir, W/no. 36 (SMC), PS. Bhaktinagar, Dist. Jalpaiguri along with seized articles (i) 06 (Six) Bottles of 60 UP Country Spirit styled as Himalayan Gold measuring 600 ml each when packed, MRP Rs. 100/- each (ii) 10 (Ten) Bottles of 60 UP Country Spirit styled as Himalayan Gold measuring 300 ml each when packed, MRP Rs. 50/- each (iii) 01 (One) Nylon Bag which used for carrying the seized articles Sl. No- 01 & 02

I, ASI Gopesh Ch. Barman of Panitanki TOP under Siliguri PS do hereby lodge a written complaint against the above noted accused person to the effect that today on 21/08/2021 at 17:05 hrs during special duty I received secret source information that, one person is selling huge quantity of country spirit at Bidhan Market under Panitanki TOP, Accordingly I informed the information to OC Panitanki TOP and as per his direction I along with ASI Surojit Mallick, C/ 1036 Lt. Jugal Srivastava & CVF 1008 Bikash Chowdhury left for PO to work out the information. On arrival at Bidhan Market near Sahji Bazar at 17:15 hrs being pointed out by the source, found that one person is selling huge quantity of country spirit containing with a Nylon bag. Accordingly I intercepted the said person with loaded articles in presence of witnesses. On search I recovered (i) 06 (Six) Bottles of 60 UP Country Spirit styled as Himalayan Gold measuring 600 ml each when packed, MRP Rs. 100/- each (ii) 10 (Ten) Bottles of 60 UP Country Spirit styled as Himalayan Gold measuring 300 ml each when packed, MRP Rs. 50/- each (iii) 01 (One) Nylon Bag which used for carrying the seized articles Sl. No- 01 & 02

On interrogation he failed to produce any valid documents/license in support of the same and stated that he sailed the same to the local people illegally with a view to earn huge money for his livelihood. Accordingly I seized (i) 06 (Six) Bottles of 60 UP Country Spirit styled as Himalayan Gold measuring 600 ml each when packed, MRP Rs. 100/- each (ii) 10 (Ten) Bottles of 60 UP Country Spirit styled as Himalayan Gold measuring 300 ml each when packed, MRP Rs. 50/- each (iii) 01 (One) Nylon Bag which used for carrying the seized articles Sl. No- 01 & 02 under proper seizure list and labeled the same in presence of witnesses and duly sign by them and also by the accused person and arrested him. The seizure was made between 17:25 hrs to 17:35 hrs and arrested the accused person u/s 41 Cr. P.C. after explaining charge against him. Total value of seized articles is Rs. 1100/-

Under the above circumstances, I am submitting this written complaint against the above noted accused person namely Babul Roy (40) S/O Lt. Mahim Roy of Netajipara, near Buraburi mandir, W/no. 36 (SMC), PS. Bhaktinagar, Dist. Jalpaiguri for starting a specific case under proper section of Law and to arrange for its investigation.
