I, PSI Newton Biswas of Matigara Police Station, Siliguri Police Commissionerate, do hereby lodge this written complaint, on producing one accused person namely Ajit Biswakarma (33) S/O Lt. Padam Biswakarma Patharghata Helapakhri, P.O- New Chamta, PS- Matigara, Dist-Darjeeling under arrest along with following seized articles viz ; (I) Total 12 (Twelve) bottles of 'Kingfisher Strong premium beer' (each bottle containing 650ml , total - 7.8 Liter, and each bottle price Rs. 130/- total Rs. 1560/-) and marked as "Exhibit A" (III) 01 (One) bottles of 'Kingfisher Strong premium beer' randomly taken from 'Exhibit A' for examination and marked as ' Exhibit A-1' under seizure list (which is enclosed herewith).to the effect that on 22.08.2021 in course of performing special raid duty myself along with ASI Tapan Das, ASI Nitai Mandal Const- 1035 Santosh Rabi Das had been to Khaprail Bazar area received a secret source information that one person namely Ajit Biswakarma of Patharghata Helapakhri under Matigara P.S has stored huge quantity of Illicit Liquor at his shop without any valid license. Accordingly I informed the matter to O/C Matigara PS. and as per his kind direction to verify the veracity of the source information. On reaching at the spot at 15: 35 hrs it was found that huge quantity of Illicit Liquor 'Kingfisher Strong premium beer' stored in the Shop of Ajit Biswakarma who has also been selling the same to the common buyers. On being seen the police party the common customers fled away from the backside of the shop. But we apprehend the above noted person namely Ajit Biswakarma. There after I called available two independent witnesses of that locality namely i)Vivek Mangar (M/ 25) S/O Vim Mangar of Patharghata Methibari, P.O- New Chamta, P.S- Matigara, Dist- Darjeeling and ii)Suman Bose (M/37) S/O Swapan Kr. Bose of Salugara, P.O- Salugara, P.S- Bhaktinagar, Dist- Darjeeling in the very presence of those witnesses I search the shop and seized the above noted Illicit Liquor 'Kingfisher Strong premium beer' after preparing proper seizure List duly signed by the two independent witnesses and apprehend the person namely Ajit Biswakarma (33) S/O Lt. Padam Biswakarma Patharghata Helapakhri, P.O- New Chamta, PS- Matigara, Dist-Darjeeling . On being asked the said person failed to produce any document for selling and storing liquor at the shop. It's a violation under Bengal Excise Act. This seizure was made on 22.08.21 in between 15.55 hrs to 16.10 hrs. Label was also prepared against total seized articles. I then arrested the accused Person namely Ajit Biswakarma (33) S/O Lt. Padam Biswakarma Patharghata Helapakhri, P.O- New Chamta, PS- Matigara, Dist-Darjeeling after preparing memo of arrest and intimating the ground of arrest. On being asked by police he stated that he running this illegal business of liquor at the said house and selling the same to the common customers since last few months without any license or permission of appropriate authority.

Hence I request you to start a case under proper section of Bengal Excise Act- 1909 against the arrested Ajit Biswakarma (33) S/O Lt. Padam Biswakarma Patharghata Helapakhri, P.O- New Chamta, PS- Matigara, Dist-Darjeeling and arrange for its investigation.
