Sir,

In producing herewith one accused person namely Pewang Tamang -19yrs s/o Pema Tamang of Sitang, Uttarpurba Shelpu, PO Sitang PS Kurseong, Dist Darjeeling at present KATHMANDU restaurant Planet Mall, Sevoke road, PS Bhaktinagar Dist Jalpaiguri along with the following seized articles as per proper seizure list:

1. 24 (Twenty four) bottles of Carlsberg premium smooth Beer (each bottle containing 330ML)  
All the articles packed in one big nylon bag.

I beg to report that I, SI Srimanta Chatterjee of Bhaktinagar PS under Siliguri Police Commissionerate lodged a written complainant against one Pewang Tamang -19yrs s/o Pema Tamang of Sitang, Uttarpurba Shelpu, PO Sitang PS Kurseong, Dist Darjeeling to the effect that on 22.08.21 at 16.15 hrs received a source information from Sevoke road under Bhaktinagar PS that one person was standing opposite Cosmoss Mall, Sevoke road with huge quantity of liquor for selling the same in the open market for his wrongful gain without any documents/license. Diarized the fact in GD vide Bhaktinagar PS GDE No-1195 dated 22.08.21. As per your kind instruction myself along with force proceeded to the PO to work out the information. We reached at the spot, sometimes after, being identified by the source our police party held raid and recovered the above noted articles from his possession. On interrogation he disclosed his identity as noted above. During local enquiry it came to learn that he is selling the same in open market for his wrongful gain without any valid documents/license. In presence of witnesses I seized the above noted articles from his possession after prepared proper seizure list and arrested him after maintain all formalities. (The seizure was made in between 18.15 hrs to 19.10 hrs)

I therefore request you a specific case may kindly be started against the accused person namely Pewang Tamang -19yrs s/o Pema Tamang of Sitang, Uttarpurba Shelpu, PO Sitang PS Kurseong, Dist Darjeeling at present KATHMANDU restaurant Planet Mall, Sevoke road, PS Bhaktinagar Dist Jalpaiguri under proper section of law and arrange for investigation..
