Respected Sir,

With due respect I, Smt. Indra Maya Singh, Wife of Late Kaviraj Singh, presently residing at Methibari, P.O. Salbari, P.S. Pradhannagar, Dist. Darjeeling beg to state that I am a senior citizen aged about 89 years and suffering from various illness.

My husband namely Kaviraj Singh was a Teacher in a Government School named Turnbull High School, Darjeeling who died in the month of May 2004 and since the death of my husband, I have been getting pension of my husband.

In the year of 2009, I have purchased a land measuring about 5.77 Decimals, recorded in R.S. Khatian No. 752, under R.S. Plot No. 135, corresponding to L.R. Plot No. 140, situated within Mouza Panchanai, J.L. No. 27, Pargana Patharghata, P.S. Matigara, Dist. Darjeeling from Sri. Rakesh Chhetri, Son of Late Prem Kumar Chhetri, resident of Methibari, P.O. Sukna, P.S. Pradhannagar, Dist. Darjeeling by virtue of a registered deed of sale being no.1-3284 for the year of 2009 which was registered in the office of the ADSR Siliguri II at Bagdogra. I have constructed a two storied building in and over the said land and residing thereon. I have one son namely Gagan Raj Singh and 4(four) daughters namely Suchita Roy, Pabitra Lohar, Rebecca Singh and Stela Wu.

Recently on 02/08/2021, I came to learn that my own son namely Gagan Raj Singh, Son of Late Kaviraj Singh, residing at Methibari, Parijat Road, Sector II, House No. 19, P.O. Salbari, P.S. Pradhannagar, Dist. Darjeeling have fraudulently got executed a deed of gift in his own name in respect of the above mentioned property.

On 29/01/2013, my son took me to the registry office situated at Bagdogra for the execution of the special power of attorney in favour of my son at his instance and persuasion; I being an old lady with feeble health and weak eyesight. My son, taking advantage of my weakness fraudulently got executed a deed of gift being no.I-704 for the year of 2013 in his own name, my son has mis-represented the facts as regards the gift deed and told me that the papers related to the special power of attorney in his favour about the said property. I have put my signatures on the documents i.e. thumb marked under the impression that I was signing the papers in regard to the special power of attorney in favour of my son. But my son had committed fraud by playing a ruse on my innocence and by taking advantage of my weakness and simplicity. Though the said deed was executed on 29/01/2013 but I came to know the said facts recently on 02/08/2021 when I was decided to make a WILL.

My son at present trying to sell out the said property to third party for the purpose to deprive me. He has also not been taking care of me and threatening all times with dire consequences. In all times, he abuse me for the purpose to oust me from my property with an intention to grab my own property for his illegal gain.

Therefore, I request you to investigate the matter and to take necessary legal action against my son Gagan Raj Singh, Son of Late Kaviraj Singh, residing at Methibari, Parijat Road, Sector II, House No. 19, P.O. Salbari, P.S. Pradhannagar, Dist. Darjeeling. And for this kindness, I shall much oblige to you.
