Subject: FIR.

Sir,

With due respect, I am producing herewith one accused persons named 1) Ramu Singh(31) S/O Ram Sagar Singh of Debidanga PS Pradhannagar Dist Darjeeling under arrest along with seized one vehicles Truck six wheelers Blue and yellow colour without number plate being loaded with sand stone (River bed materials).

I beg to report that today on i.e 21.08.2021 I was engaged in Mobile van duty PS area with C/ 207 Niladri Sarkar and C/ 473 Amrita Sarkar of PDN vide GDE No 1421 dated 21.08.2021 . I was patrolling at Milan more area under Pradhannagar PS .During mobile duty at 16.05 hrs I found that one truck six wheelers Blue and yellow colour without number plate is coming from Sukna Railway Station Side to Milan more side loaded with sandstone (Riverbed materials),We tried to stop the said truck but driver fled way with truck ,Somehow we chase the said truck and stop truck and detained the driver , on interrogation he disclosed his identity which noted above . I asked to the above noted driver to produce any valid document in respect of the loaded sand and vehicle paper ,but he failed to produce any kind of documents ,He also stated that he loaded the said Sand stone (Riverbed Marital) from Mahananda River bank ,near Milon More under Pradhannagar PS illegally for his wrongful gain . So I arrested him under section 41 Cr.P.C. and seized the loaded trucks under proper seizer list seized in between 16.25 hrs to 16.55 hrs .




