I PSI.Chetan Dongal of Pradhannagar PS, SPC would like to lodge this written complainant against the above noted accused person to the effect that today on 21.08.21 at 19:05 hrs myself along with force CV/128 Ajay Kr Sahani,CV/223 Swapan Chettri left from PS for Special raid van duty vide PDN PS GDE NO 1431 21.08.21 .During special duty I received an information that one person namely Rambabu Sahani(40) S/O Sito Sahani of Coolie para,Ps.Pradhan Nagar ,Dist-Darjeeling has storage huge quantity of illegal liquor in his petty shop situated near Hanuman Mandir under Pradhannagar PS and selling the same in his shop .Accordingly I share the information to you and as per your kind instruction myself along with force rush to the spot and hold raid in the shop noted above and detained the above noted person and on being search his shop recovered above noted articles , On demand he failed to produce any valid document in respect of recovered articles .On interrogation he admitted that he is selling the same illegally without obtaining valid document for his illegal gain. Accordingly, I seized & label the above noted articles in between 17:45 hrs to 18:40 hrs and I arrested him.


