I SI Khela Murmu of Pradhan Nagar Police Station under Siuliguri Police Commissionerate do here by lodge this written complaint to the effect that today i.e 21.08.2021 in between 17.15 to 18:25 hrs myself along with C/207 Niladri Sarkar and c/473 Amrita Sarkar of Pradhannagar Police Station had been to Champasari more area, PS-Pradhan nagar, Darjeeling and found the above noted persons were moving there without mask and which was promulgated by Govt of West Bengal. they violated the order for combating the spread of COVID- 19 as per order of Govt of West- Bengal vide order No 647-ISS/2M-22/2020 dated 15.05.2021 and Notification number 347 -01.S.S / 2M-24/2020 dated 3rd June ,2020 and Memo No 486-CS/2021 dated 24th April , 2021 in view of break-out of pandemic COVID-19

Accordingly, I arrested them u/s 41 CR.P.C in c/w the above case. Hence, I request you for starting a specific case against the above noted arrested persons and arranged to proper investigation of the case.
