I, Nandini Khatun W/O Nasib Alam, resident of near Sister Nivedita School, Airport More, Lower Bagdogra, P.O. & P.S. Bagdogra, Dist. Darjeeling, beg to report you that I was married to Nasib Alam S/O Surya Alam of Airport More Bagdogra on 05.12. 2015 and there is one daughter named Nushrat Khatun now aged about 4 years from our wedlock and he forcibly converted my religion from Hindu to Muslim against my will after the said marriage. That after one year of the said marriage my husband began to torture me both physically and mentally in different ways almost every day and few days after it came to my knowledge that he has illicit relation with one Punam Roy of Biman Nagar, Bagdogra who is a lady of bad character. My husband regularly goes to meet her and I have caught them red handed several times.

That when I request and suggest my husband not to do such immoral act, he starts to hit me with feast and blows and also with hard substances out of which I sustained bodily injuries for several times yet, I was bearing all such ill acts of him for the sake of prestige of both of us and also of family. Now, he is intimidating me that if I resist him from meeting Punam Roy then he will put an end of my life.

Sir, I therefore, request you to kindly take necessary action against both of them so that peace life may come back to my family and for that act of kindness. I shall remain ever grateful to you.
