Sir,

With due respect, I SI Bapi Ch Dey of Bagdogra PS, do hereby lodge this written complaint against the following arrested persons namely 1) Biki Basfore 21yrs s/o Jogendra Basfore of Tiger busty PS, Bagdogra Dist, Darjeeling ii) Biswanath Mahal 18yrs s/o Mantu Mahal of Vill+PO, Pipepara PS, Malhati Dist, Birbhum iii) Rajat Roy 28yrs s/o Mithilesh Mohon Roy of Gosainpur Railway Quarter PS, Bagdogra Dist, Darjeeling iv) Sonu Kr Sahani 18 yrs s/o Tuntun Sahani of Maszidpara Airport More PS, Bagdogra Dist, Darjeeling order vide Memo No. 486/CS/2021 dated 24.04.2021 and order No 647-ISS/2M-22/2020 dated 15.05.2021.

The facts of the case in brief is that today on 22/08/2021, I along with ASI Subash Ch Roy & force were engaged in evening van duty Bagdogra PS, vide GDE No 1481 Dtd, 22.08.21 and during duty, found that at about 15.35 hrs the above noted persons was moving freely without wearing Facial Mask at Panighata more area completely violating the lockdown measures issued by the appropriate authority. I repeatedly cautioned them and warned them to wear Mask but they did not listen rather showed negligent and casual attitude and their unlawful movement found likely to spread covid -19 dieses which is dangerous to life. Then above noted persons could be apprehended. On interrogation, they all disclosed their names and address as noted above. On further asked, they all admitted that they all were aware of the order to wear facial Mask in public place. As they had violated the order of State Government vide No. 753/IV-ISS/2M-22/2020 Dated 29/07/2021 and recent order No. 753/V-ISS/2M-22/2020 Dated 13.08.2021 and earlier orders promulgated to contain the spread of Covid-19 virus. Therefore, they were arrested and brought to Police Station and were in Police Custody

Under the above facts and circumstances, I request you that a specific case against the aforementioned persons may kindly started with suitable sections of law.
