I.O is present today with necessary explanation.  
Perused the case record and CD.

It appears from the record that FIR was registered at P.S Goalpokher as Case No 132/2021, dated 18.05.2021 u/secs.498A/323/307/34 of I.P.C & r/w sec.3/4 of D.P.Act.

According to the I.O, during course of investigation, he detected the place of occurrence of the alleged offence falls within the jurisdiction of P.S Bagdogra, Dist. Darjeeling. Thus, he prayed before this Court to pass an order to transfer the case record to the Ld. A.C.J.M., Siliguri, Dist. Darjeeling.

It is pertinent to mention herein, in view of the zero FIR concept, a complaint can be lodged at any P.S although the alleged offence is committed outside the original jurisdiction of such P.S. Subsequently, such FIR is supposed to be transferred to the P.S of its original jurisdiction by the P.S wherein it is lodged. In the instant case the fact regarding place of occurrence of offence was within Bagdogra has been detected during investigation of this case.

In view of these facts, the Court finds sufficient merits in the prayer of I.O, as P.S Bagdogra is within the jurisdiction of Dist. Darjeeling which is beyond the jurisdiction of this Court. Thus, the prayer made by the I.O is considered and allowed.

Accordingly, let the entire case record be transmitted to the A.C.J.M, Siliguri, Dist. Darjeeling at once.

I.O is directed to hand over the case diary to I/C P.S Bagdogra and submit a compliance report before A.C.J.M, Siliguri, Dist. Darjeeling and shall also send a copy of the same before this Court.

GRD is directed to do the needful to transmit the case record to the A.C.J.M, Siliguri at once, upon retaining a skeleton of the same and send a copy of this order to the I.O at once.



Most respectfully Sheweth -

- 1) That complainant is the wife of accd. Kush Karmakar and their marriage was solemnized on 13.12.2013 according to Hindu rites, religion and customs and the marriage is still subsisting. The other accd. persons are the in-laws of the complainant, and all of them have been residing jointly under common roof.
- 2) That, at the time of marriage the parents and relatives of the complainant gave sufficient gifts and articles in terms of ornaments made of gold, ornaments made of silver, furniture including cash of Rs. 30,000/- as dowry to the accd. persons and after marriage the complainant brought at her matrimonial house and began to lead their conjugal life.
- 3) That, from the very inception of their marriage it reveals that the accd. persons were not satisfied with the articles and ornaments including the quantum of amount presented in the marriage and after few days all the accd. persons in connivance with each other started to create pressure upon the complainant to bring a sum of Rs. 1 Lakh from her parent's house as dowry but the parents of complainant could not fulfill the illegal demand of the accd. persons as a result all the accd. persons in furtherance of common intention subjected the complainant with cruelty and harass her both mentally and physically to extort their illegal demand of dowry.
- 4) That, the accd. No. 1 is an alcoholic person and has a habit of gambling and he used to slang and beat the complainant <sup>at most</sup> everyday. The all accd. persons used to abuse the complainant in filthy and provocative languages and assaulted the complainant off & on and used to threatened the complainant that unless their demand be fulfilled, the complainant can never be able to lead happy peaceful conjugal life. The accd. persons had no love and respect towards the complainant and used to treat her as nothing more than a maid servant.
- 5) That, the complainant was bearing all the torture with a hope that by the lapse of time the accd. persons may change their attitude but nothing fruitful happened and day by day accd. persons aggravated their torture and made the life miserable of complainant and in the month of November, 2014 over the issue of the demand of dowry all the accd. persons brutally assaulted the complainant and the accd. persons drove the complainant out from her matrimonial home and said that they will only allow the complainant to reside there after fulfilling their demand of dowry.
- 6) That, after 3 months a home salish was held in presence of the parents of the complainant and the family members of the accd. persons, then the accd. persons allowed the complainant to reside with them at her matrimonial home and a decision was taken with a promise that the accd. persons will not assault the complainant anymore.
- 7) That, even after the salish the accd. persons continued their torture upon the complainant and in the meantime the complainant conceived pregnancy and even in such critical period all the time accd. persons continued to inflict inhuman mental and physical torture upon the complainant to fulfill their illegal demand of dowry and ultimately on 09.07.2015 complainant gave birth a child namely Anish Karmakar.

8) That even after giving birth a child the accd. persons continuously insulting and torturing the complainant to bring money from her parental house and threatening the complainant that if the parents of complainant will not fulfill the illegal demand of dowry then they will drive the complainant and her child out of their house.

9) That accd. no.1 is an alcoholic person and has a habit of gambling and was assaulting complainant everyday demanding money from her parental house and accd. no.1 was not taking care of the complainant and her minor child and was not fulfilling their necessities too.

10) That, finding no other alternative complainant started working in a private company namely "Nutracos Pvt. Ltd." as a health supervisor to support her family, but as accd. persons did not like the complainant working they raised finger on her character and the complainant had to left her job.

11) That, complainant even after consuming such extreme humiliation for the sake of her child continued to lead conjugal life with the accd. No.1 and all the accd. persons and as usual they subjected complainant with cruelty for extorting their demand of dowry.

12) That, lastly on 15.01.2021 all the accd. persons over the issue of non-fulfillment of their demand of dowry brutally assaulted complainant with fist and blow and when complainant raised objection all the accd. persons dragged complainant inside a room and attempted to kill mcomplainant by strangulating her neck with a Gamcha and somehow complainant struggled to survive and complainant started hue and cry and hearing her cry, the passersby people came there and saved the life of complainant from the ugly hands of the accd. persons and with the help of the said passersby complainant went to her parental house along with her minor child.

13) That, after the incident complainant went to local Police station for several times to lodge FIR against the accd. persons but neither the Police registered any case nor gave any receipt of the complaint.

14) That on 29.03.2021 finding no other alternative complainant Sent an application before the Superintendent of Police, at Islampur Police District but in vain.

15) That, in the above circumstance the complainant, files the present complaint seeking a direction to the I/C Goalpokher P.S. for starting a case and investigate the incident in the proper manner

Under the facts and circumstances your Honour will be pleased to take cognizance of the offence against the above named accused persons and this complaint, petition be sent to I/C Goalpokher P.S. for treating the same as F.I.R. and investigate the matter in proper manner.
