Sir,

I, Sri Babu nanda Mishra, son of Daroga Mishra, resident of Salugara, P.O. – Salugara, P.S. – Bhaktinagar, Dist. – Jalpaiguri, beg to inform you that I am one of the partners of a Partnership Firm under the name and style Care N Cure Nursing Home, having its principal place of business at Mousumi Complex, above SBI Matigara hat Branch, Khaprail More, P.O. & P.S. – Matigara, Dist. – Darjeeling, beg to inform you that I along-with two others namely Smt. Ranju Singh and Sri Braj Lal Yadav, being the partners of the said firm preferred before the Ld. District Judge at Darjeeling under Section 9 of Arbitration and Conciliation Act, 1996 a case being Misc. Judicial (Arbitration) Case No. 12/2021 against Dr. Nitin Naik and three others on 14.06.2021 and after hearing the Ld. Court was pleased to pass an injunction order on 15.06.2021 restraining the respondent number 1 and 2 as well as their men and agents and employees or any other persons under their control for creating any other obstruction in entering into the compound of Care N Cure Nursing Home or any part thereof by the petitioner or their employees and to cause any interference into the management of the partnership business by the petitioner till 14.07.2021. That thereafter the said order was extended from time to time. That subsequently I along with my other partners enter into the said nursing home compound with the help of your authority and started to visit the management of our partnership business. That today one person namely Ajit Singh who supposed to be appointed as bouncer by Dr. Nitin Naik directly interfering with the management of the nursing home and trying to restrain us to perform any activity in the nursing home and on being protest he said that he will not obey the

order of any Ld. Court or he has no respect of any police authorities and he is not allowing us to take any patient in the nursing home and always trying to threaten to our management staffs.

It is further mention herein that the said Ajit Singh also using such filthy and unconstitutional languages towards our patients and the attendance of the patients.

Therefore it is requested to you kindly take serious action against the said Ajit Singh as per the law of land by initiating a specific case against them.
