With due respect I Sima Roy Wife of Sri Manik Roy, resident of Bhupendra Nagar, SMC Ward No. 42, P.O Salugara, P.S Bhaktinagar, Dist Jalpaiguri (West Bengal) begs to state that on 24.07.2021 at about 9 A.M suddenly Smt Tumpa Roy W/O Sri Jit Roy and her husband i.e Jit Roy entered into the house of my daughter in law Molina Roy W/O Palash Roy house which is adjacent to my house in the same locality. That at the relevant time she was alone and after entering into the house of my daughter in law, Smt Tumpa Roy and her husband Jit Roy started quarreling with her. That my daughter in law raised voice for help after hearing the sound of my daughter in law I rushed to the house of my daughter in law and found that they forcefully dragged her inside the room and with the intent to murder her they pressed the mouth of my daughter in law with pillow and started strangulate her by her odhani. That they when see me that I arrived in the said room they left my daughter in law and started quarreling with me and they beat me, I sustain injury in my head and chest and they also tried outrage my modesty. That after hearing the sound local people started gathering and seeing the local people they fled away. That their intention to kill my daughter in law. That I am unable to lodge this complaint earlier as because my treatment is going on under the doctor of Siliguri Government Hospital.

So, I therefore request before you to kindly look into the matter and do the needful under the provision of law. I shall be highly obliged for this act of kindness.
