inform you that as follows

That on 22-08-2021 at about 2:00 PM. the abovesaid  
persons visited my house for leisure but at about 9:00 PM.  
after they departed from my house one SANTIB PAUL  
S/o. Tapan Paul, my neighbour, who was the Ex-husband  
of my daughter suddenly attacked my daughter and  
son-in-law with fists and kicks over their persons and  
used strong and filthy language towards them. The  
incident took place few meters away from my house.  
Somehow they were rescued with the help of local people.  
They received several injuries on their persons.

That after the said incident, my daughter and son-in-law  
returned my house, with a fear of subsequent attack by  
the said SANTIB PAUL. After knowing the said incident  
when I visited the assaultant's house for protesting he  
suddenly became furious and tried to assault me  
and threatened me with dire consequences that "I shall kill  
you all within short time. No one can save you all from  
my hand. I swear on god." Since then till today he have  
been constantly threatening me and my family members.

I therefore request you to kindly take necessary  
legal steps against the said SANTIB PAUL and save us from  
his hands as we are in an anticipation of life threat.
