I, PRADIP Roy, son of Late Manindra Nath Roy, resident of
Sukantanagar (North), Suryashikha Barani, W/Ho 38 under S.M.C., G.O.
Rabindra Sarani, P.S. Bhaktinagar, Dist. Jalpaiguri, would like to
inform you that as follow :-
1) That SISMITA ROY w/o. Sankar Sharma and SANKAR SHARMA
S/o Godai Sharma, is my daughter and son-in-law
respectively. Both reside at Baghajatin colony- P.O. P.L.P.L. Purkhan-
garh, Dist. Darjeeling.

That on 22.08.2021 at about 2:00 PM. the abovementioned
persons visited my house for leisure but at about 9:00 PM.
after they departed from my house One SANJIB PAUL
S/o. Tapan Paul, my neighbour who was the Ex-husband
of my daughter suddenly attacked my daughter and
son-in-law with fists and kicks over their persons and
used strong and filthy language towards them. The
incident took place few meters away from my house.
Somewhat they were rescued with the help of local people.
They received several injuries on their persons.

Received on 24/08/21 at 19:40 hrs returned my house, with a fear of subsequent attack by
the said SANJIB PAUL. After knowing the said incident
on 24/08/21 when I visited the assailants house for protesting he
suddenly became furious and tried to assault me.
and threatened me with dire consequences that "I shall kill
you all within short time. No one can save you all from
my hand. I swear on god." Since then till today he have
been constantly threatening me and my family members.
Therefore request you to kindly take necessary
steps against the said SANJIB PAUL and save us from
his hands as we are in an anticipation of life threat.
