Respected Sir,

With due respect I, **SRI NABARUN DEY**, Son of Sri Bapi Dey, Resident of 6, Baghajatin Park Road, Near Manasha Mandir, Siliguri, Ward No. 17 of SMC, Siliguri, P.O. & P.S. Siliguri, Dist. Darjeeling, would like to lodge this written complaint before your good office to the effect that today in the evening time at about 08.30 P.M., when I along with my friends Sri Sanjib Singh and Sri Ajay Roy were gossiping and discussing with each other and also consuming hard drinks at Bar Cum Restaurant of Gateway Hotel (Popularly called as "**The Mask**") at Sevoke Road, Siliguri, suddenly, some persons numbering about 10 to 15 persons who were also seated there, attacked upon me with the broken wine bottle and broken glasses and hit me on my head with an intention to murder me as previously one year back, one disputes were cropped up in between us and subsequently, the said disputes have been settled amicably. Due to their said attacked and assault on my head with sharp cutting broken wine bottle and glasses, I have received severe injury on my person and when my friends try to rescue me from their hand, they have also assaulted them with fist and blows and at the time of assaulted me, they have snatched my golden chain weighing about 33 grams valued Rs. 1,65,000/- only approx and they have also forcefully took one golden finger ring from my right hand middle finger and I have also received injury on my right hand when they were snatching my golden finger ring from my finger of the right hand and when myself along with my two friends started shouting Bachao Bachao, the other customers of the said Hotel and staffs gathered there and left the place and at the time of leaving the spot, they threatened me and my friends with dire consequences by saying that if we came again, they will not hesitate to murder us and nobody will do anything against them. The entire incident has been recorded in the CCTV Camera of the Bar Cum Restaurant of "**The Mask**" of Hotel Gateway in between 08.32 P.M. to 08.40 P.M. I can identify the persons

who assaulted me and my friends and their names are (1) Bijay Sahani, (2) Pawan Kumar, (3) Dipak Kumar, (4) Subham Jaiswal and others and all the persons are the inhabitants of Ganga Nagar, Ram Ghat area. The aforesaid miscreants attacked upon me with the sharp cutting broken glasses and broken wine bottles with an intention to murder me in a pre planned manner and still now, my life is in stake in their hands and at any time, they may again attack upon me and my friends with an intention to destroy our life. Due to my serious injury on my head, I went to Siliguri District Hospital where the attending Doctor treated me and still now, I am undergoing treatment.

I, therefore, request you to kindly investigate the matter properly and please take strong legal actions against the miscreants namely (1) Bijay Sahani, (2) Pawan Kumar, (3) Dipak Kumar, (4) Subham Jaiswal and others as per the provision of law and obliged thereby.
