about 04.30 pm, the following persons came
in front of my house at Santoshi Nagar, noted
above, namely (1) Biki Mehta S/O Sri Bhubu
Mehta, resident of near Santoshi mandir,
Santoshi Nagar, ward No. 5 SMC, P.O. & P.S.
Siliguri, Distt - Darjeeling, alongwith 03 (three)
other unknown persons, restrained my father
namely, Nand Lal Kumar Jaiswal S/O Late
Gauri Shankar Jaiswal, of above noted address
and started abusing him in filthy language
and when he protested, they started beating
him with fist and blow and threatened him
for dire consequences.

My said father, Nand Lal Kumar Jaiswal
received severe injury on his person and
immediately shifted to Siliguri Distt Hospital
and treated there.

Sir, the above named alleged
persons namely, Biki Mehta & his 03 (three)
unknown associates are very desperate &
