In producing herewith two (02) arrested accused persons namely (i) Sibumunda (28), S/O Lt. Ashilal Munda of Nischintapur, T.G PS - MTG, Dist - DJG, (ii) Santosh Darjee (43), S/O Ganga Bdr. Darjee of Garidhura, PS - Kurseong, Dist - Darjeeling arrested u/s 41 Cr.P.C.

I, SI Md. Sanauallah of Matigara PS SPC to the effect that on 25.08.2021 while performing SPL Mobile duty under Matigara PS area found Two persons namely (i) Sibumunda (28), S/O Lt. Ashilal Munda of Nischintapur, T.G PS - MTG, Dist - DJG, (ii) Santosh Darjee (43), S/O Ganga Bdr. Darjee of Garidhura, PS - Kurseong, Dist - Darjeeling were loitering near City Centre, under Matigara PS area without wearing mask and not maintaining social distance and violating the Govt.
