Sir,

In producing herewith the arrested accused person namely Aftab Islam (20 yrs), S/O- Sariful Islam, of- Kawakhali, PO- Sushruta Nagar, PS- Matigara, Dist- Darjeeling do here by lodge this written complaint against the accused person.

I, ASI Dulal Dey presently posted at NBMC OP (under Matigara PS) SPC today i.e. on 26.08.2021 at 14.05 hrs, in course of "Duware Sarkar Camp" L/O duty at Kawakhali Junior High School vide NBMC OP GDE No. 593 Dated 26.08.2021 MCC No. 1575 Dated 26.08.2021 I had apprehended one person red handed who was extorting money from public in general who had come at "Duware Sarkar Camp" at Kawakhali Junior High School taking the advantage of their ignorance for filling up the forms of different Government Welfare schemes and thus cheated them intentionally. Accordingly, I informed the matter O/C NBMC OP, as per his direction, myself along with force who were deployed at duty at the "Duware Sarkar Camp" at Kawakhali Junior High School under NBMC OP arrested the above noted accused from the spot. During further interrogation, the above noted person disclosed his name and identity as noted above. On being asked, the above noted accused person admitted that he was taking money from the public in general for filling up Government forms of Welfare Schemes although there was help desks set up by the local administration for the said purpose. He also scares the general public that if they did not fill up their Government Welfare schemes forms from him they will not get the benefits from the Government in future. I also seized 11 (eleven) numbers of Indian currency ten rupees total amounting Rs. 110/- and brought him to PS after observing all legal procedures.

Under the above facts and circumstances I therefore pray that a specific case under proper section of law may kindly be initiated against the above noted arrested accused person and kindly arrange for its investigation.
