Subject: (FIR against Ranjit Sahani for physical and sexual assault)

Respected Sir,

I Tunna Shah, S/O Shatrughan Shah, aged 32, resident of New Darjeeling Morh, would kindly like to bring to your attention about the mental and physical abuse which I had to face at the hands of a person named Ranjit Sahani, S/O Ram Prasad Sahani, resident of Durgagari, New Darjeeling Morh, P.O. + P.S. Pradhan Nagar, Siliguri.

I come from a humble background and run a small eatery near Tower Bangla for the past two years and everything was going on smoothly however in the month of May Ranjit Sahani came to my shop in a drunken mode and started to misbehave with my children (Ankit Kumar Aged 9 years, Ajit Kumar 7 years and Simran Kumari aged 5 years). When Ranjit Singh Started to touch my children inappropriately specially my minor daughter I intervened in order to protect my daughters dignity and I asked him to take his lecherous hands off her, he started hurling abuses at me and started to beat me up and when my wife Shanta Devi came to my rescue he started hitting her and tearing her clothes off. During the scuffle he repeatedly hit me on my ears which have led to the loss of hearing in my left ear and if people from the nearby shops not come to my rescue I would have suffered even greater degree of damage.

On 20th August 2021 around 7:40 PM Ranjit Sahani once again came back to our shop in an inebriated state and started hurling abuses to me and my wife. However he did not only stick to verbal abuses but also started to hit me and my wife. In the state of chaos my son Ankit Kumar went to seek help and informed the traffic officers stationed in New Darjeeling Morh Traffic, who immediately responded to the call of aid. When Ranjit Sahani saw the police coming to our rescue he immediately ran away from the scene and the police tried to catch him but he managed to give them the slip.

Ever since this incident I have been living in perpetual fear for not only the safety of my life but also for the safety of my wife and three children. We have not yet reopened our shop due to the fear that has been instilled in us by the atrocities committed by Ranjit Sahani.
