Subject: Sexual Assault in Pradhannagar

Respected Sir,

I am, Nivedita Lama, D/o Augustine Janang currently residing in Prayas Apartment, Behind Marganate School, Nivedita Road, Pradhannagar - 734003. On 24th August, 2021 around 9:30 pm while returning home with two of my sisters by the lane connecting Champasari Market and Meghrad Saha Sarani Road i.e. alongside the Transit Camp, a person on his scooter sexually assaulted me. The nature of assault was that he came speedily on his scooter and grabbed my right breast while speeding on his scooter. We couldn't identify the person as his face was fully covered with his helmet and the number plate couldn't be seen as it was dark. The incident occurring within 15 meters from the apartment. I live in and even with security cameras being put up by the Transit Camp across the lane is very concerning.

I would like you to register this complaint and look into the matter of security and safety in this area as this lane is known to have had a number of criminal misdeeds.

I would be obliged if you would kindly take action and
strengthen the security in the area so that such incidents do
not occur again and men of such demeanour are not
encouraged to conduct more heinous crimes.
