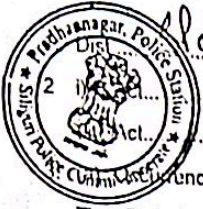

Respected Sir,

My name is Bhupal Chhetri and I am lodging this FIR to let you know that I have paid an amount of Rs. 590000 To Mr .Manish Sharma for bringing a consignment containing my Gym goods from Meerut to Siliguri. I have paid the amount via bank transfer to his account. I have also paid Rs.70000 by cash to him.

The amount was first paid on 5/11/2020 via bank transfer from my account number- 918010059648586 to the account number of Mr. Manish and his wife Mrs.Anjali Sharma. He was supposed to ship the goods on January'21 but he didn't do that. I have been following up with him over the phone since the month of January but no use. He used to say that we will be shipping soon but that did not happen. I have also requested him to either refund the amount but that too did not happen.

Till now he has only shipped goods of Rs.2,00,000. The rest of the goods are still pending. He has also stopped receiving my calls and did not pay any heed to my calls. I request you to look into the matter as I have invested a lot into my materials. His credentials are below:
