I, the undersigned would like to inform you that I am constituted Attorney holder of [1] Smt Balo Oraon, wife of Fagu Oraon, [2] Smt Somari Xalxo, wife of Joseph Xalxo, [3] Smt Kalo Pashyan, all are daughter of Late Chamru Oraon (Oraw), and resident of Middle Palash, P.O. 
