**Subject: Illegal demand of money by giving fear of death and attempt for abduction by force.**

Respected Sir,

With due respect I Sri Jay Prakash Yadav, Son of Satya Narayan Yadav, resident of Ground Floor, Sharda Green Apartment, Opposite Virama Resort, Dagapur, Police Station Pradhan Nagar, Dist. Darjeeling, do hereby state before you as follows:

1. I am the care taker of my employers Sri Chandreshwar Prasad resident of Hill Cart Road, Siliguri and Sri Dilip Prasad and my employers some few months back purchased land measuring more or less 26 Kathas situated at Mouza Kalkut, P.S. Pradhan Nagar, Dist. Darjeeling and the said land also sold by my employers to other person.

2. Today on 26.08.2021 at around 9:00/9:15 A.M. when I was at my house then one person by name Sri Pintu Gupta, Son of Kesav Prasad Gupta, resident of Maruti Apartment, Flat No. 2A, 2nd Floor, near Pragati College, Barogharia accompanied by another one person whose name I do not know, came to my house and just as I opened the door, the said two persons after entering my house, caught hold of me by neck and started to physical assault upon my body by fit and kick and pushed me due to which I fell down on the bed in my drawing hall.

Before I could understand anything, my wife and other family members rushed to save me and with their help I could get up from the bed and then the said Mr. Pintu Gupta in presence of his accomplice started demanding Rs. 5,00,000/- (Rupees Five Lacs) from me as their syndicate tax as any person purchasing or selling land in the area of Kalkut is required to pay gunda tax to them as was what said to me by the said Mr. Pintu Gupta.



Then I requested him to contact my employers as I have no power and/or authority to pay any amount towards gunda tax and/or syndicate tax and on hearing this both Mr. Pintu Gupta and his other accomplice tried to take me alongwith them by using force so that they could realize their illegal demand of money from my employers.
5. Due to strong resistance by my wife and my brother in law (my sister's husband namely Sri Subhash Yadav) who were present at the house they could not manage to take me with them by force. Due to hue and cry some other residents of the apartment came towards my house for help and then seeing several people, Pintu Gupta and his accomplice ran away in car bearing registration number WB 74 BC 2360 and at the time of fleeing they were shouting that they will take revenge from me or else I handover Rs. 5,00,000/- (Rupees Five Lacs) to them which is their illegal demand.

Hence I request you to kindly register my written complaint as FIR and take necessary legal action against the said Sri Pintu Gupta and <sup>(m no</sup> 34473 his other accomplice, who was with him and all others involved in this illegal syndicate.
