I, **DIPA MISTRI**, D/o. Ratan Mistri, resident of Natun Para, Gossainpur, P.O. & P.S. Bagdogra, District Darjeeling, in the State of West Bengal, India, would like to state that I came to know on 15.08.2021 that two (2) fake Facebook accounts has been opened in the name of Dipa Roy. The account shows my photos & all my details. The person involved have posted my details & my phone number with comment to contact me as a call girl. I have strong belief that the persons involved in the shameful act knows me very well and has posted my pictures only to malign my image and prestige in the society. On this issue I lodged a FIR on 20/08/2021 at Cyber Crime Police Station, Siliguri but after I lodged the FIR one person namely **Rinku Kumar Harijan @ Rahul Ray**, S/o. Dhiren Kumar Harijan, R/o. Taowabhita, P.S. Putibhita, District Kishanganj, Bihar, sent six (6) voice call sms in my cousin brother's phone number (6297457260) and threatened my brother. My brother forwarded the voice call sms to me. He was using slang language and threatened my brother with dire consequences. He also said that he would viral my video in my home town locality as I have lodge the complaint. I again came to know that he has again opened a Facebook account in the name of Akash Puchki and posted my photos in that account. I am being mentally harassed by Rinku Kumar Harijan @ Rahul Ray and now I have strong belief that he would again try to malign my image and prestige in the society.

It is requested before you to kindly take necessary strict action against Rinku Kumar Harijan @ Rahul Ray so that he can be punished for the wrongful act & the fake Facebook account can be closed immediately.
