Sir,

With due respect in producing herewith one accused person namely Krishna Dutta (36), S/O Lt. Amar Dutta of Matigara, PS - Matigara, Dist -- Darjeeling under arrest, I S.I. Subash Ch. Roy of Bagdogra Traffic Guard beg to state before you that on 27.08.2021 during performing my special raid Duty at Khapraïl More Traffic Point under Matigara PS area vide Bagdogra Traffic Guard GDE No. 215, dated - 27.08.2021 at around 19:00 hrs found one Motor cycle rider coming from City Centre side and heading towards Shivmandir area without wearing Helmet and mask. Subsequently, I along with my accompanied Traffic force signaled him to stop but he did not obey and tried to flee away from the spot with his Motor cycle bearing Reg. No. WB -74 AF 1738. But somehow we managed to apprehend the person who being interrogated disclosed his identity as above and subsequently, being asked regarding not wearing mask violating Govt. Order vide No.403/2020-DM-1 (A) Date- 29.04.2021, he started abusing us with filthy languages and also restrained me and my accompanied forces to discharge our Govt. duty. Accordingly, I arrested him u/s 41 Cr.P.C observing all formalities.

Hence you are hereby requested to start a specific case under proper section of Law against the above noted accused person namely Krishna Dutta (36), S/O Lt. Amar Dutta of Matigara, PS - Matigara, Dist -- Darjeeling and arrange for its investigation.
