In producing herewith one Female accused person namely Jhuma Barman-(19 yrs.), D/O Subhash Barman, of Adarshanagar Colony near Adarshanagar Football Ground, W/NO-04, PS- Siliguri, Dist - Darjeeling along with the following seized articles as per proper seizer list.

1 13(Thirteen) pet bottles of Himalaya Gold 60up premium country spirit (each bottles containing 300 mL & MRP Rs.50/-)

I ASI Sanjay Hasda of Khalpara TOP, PS Siliguri under Siliguri Police Commissionerate lodge a written complaint against the above noted person to the effect that on 27.08.2021 at 16:05 hrs. received an information from Adarshanagar Colony near football ground, W/NO-04, under Siliguri PS that one person has gathered huge quantity of illegal liquor which kept in her house which was kept in one gunny bag for selling the same in the open market for her wrong full gain. Diarized the fact in GD vide Khalpara TOP GDE NO -937/21, Dated-27.08.2021. As per your kind instruction myself along with ASI Uttam Kumar Dhar, C/ 1072 Anand Thakuri L/C 1216 Puspanjali Yonzon and proceeded to the PO to work out the information at 16:15 hrs. we reached at the near Adarshanagar Colony near football ground W/NO-04 sometimes after being identified by the source our police party held raid and recovered the above noted articles from the possession of above referred person. On demand she could not produced any valid license/documents in support of said liquor. She become nervous and admitted her guilt before us and stated that she sell same in open marked for her wrong full gain. In presence of witnesses I seized the above noted articles from her possession after prepared proper seizer list and level and took signature of the accused person one bottles taken as sample. (The seizure was made in between 16:25hrs. to 16:55hrs.) I arrested the accused person by lady police U/S 41 Cr. P C and issued Memo of arrest.

I therefore request you a specific case may kindly be started against the accused person namely Jhuma Barman-(19 yrs.), D/O Subhash Barman, of Adarshanagar Colony near Adarshanagar Football Ground, W/NO-04, PS- Siliguri, Dist - Darjeeling under proper section of law and arrange for investigation.
