Sir,

In producing herewith one accused person namely; Suresh Sahani (45yrs) S/O Lt. Sattyen Sahani of Maharaj Colony, near Kachra math, W/no-04, PS- Siliguri, Dist-Darjeeling along with the following seized articles vize- i) Twenty two (22) sealed Bottles of Himalayan Gold 60 UP country sprit each bottles containing 600 ml. labeled as Himalayan Cndeavour PVT. Ltd Siliguri West Bengal @ Rs. 100/- each (amounting 22x Rs. 100 = Rs. 2200/-) as per seizure list.

I, SI Hiru Kanti Sarkar of Siliguri PS, SPC do here by lodged a written complainant against the above noted person namely Suresh Sahani (45yrs) S/O Lt. Sattyen Sahani of Maharaj Colony, near Kachra math, W/no-04 PS- Siliguri, Dist-Darjeeling, to the effect that today i.e. on 27.08.2021 hrs at 14:35 hrs received a source information that at Maharaj Colony, PS- Siliguri above noted accused person was busy to sale Id. Liquor illegally at his house situated at Maharaj Colony, ward no. 04 under Siliguri PS in order to clandestinely disclose the same. Accordingly the fact is diariced in GD vide Siliguri PS GDE no.1641 dt. 27.08.2021 and informed the fact to I/C Siliguri PS. As per his direction I along with, ASI Siben Sarkar, and CV/622 Ramanath Barman CV/283 Prosenjit Dey left Maharaj Colony, near Kachra math, ward no. 04 SLG PS vide Siliguri PS GDE No.1642 dt.27.08.2021 to verify the veracity of the information. On reached at 15:05hrs there and as identified by source cordoned above noted area where he was selling illegal alcohol. On seeing the Police party the above noted person tried to escape the spot but we managed to apprehend the above noted person and on interrogation, he disclosed his name and identity as noted above. On searching Twenty two (22) sealed Bottles of Himalayan Gold 60 UP country sprit each bottles containing 600 ml. labeled as Himalayan Endeavour PVT. Ltd Siliguri West Bengal @ Rs. 100/- each (amounting 22x Rs. 100 = Rs. 2200/-) which was kept concealed in his house. On being interrogation he could not produced any valid documents in respect of said liquor. He also stated that he is doing this liquor business since last 01 year approx for wrongful gain. Accordingly I seized the same in presence of witnesses duly signed by them. The seizure and label was made in between 15:35hrs to 16:35hrs. on being asked he stated that he used to sell the same to locality without any valid documents as he has violated the norms of Bengal Excise Act as such I arrested him u/s 41 Cr.P.C. after observing all sorts of rules for selling the said seized articles without any valid license.

I therefore pray before your honor that a specific case may kindly be started against the arrested accused person namely Suresh Sahani (45yrs) S/O Lt. Sattyen Sahani of Maharaj Colony, near Kachra math, W/no-04 PS- Siliguri, Dist-Darjeeling , under proper section of law and arrange for its investigation.
