Sir,

In producing herewith one arrested accused person namely Gopi Lama (74) S/O Lt. Kajiman Lama of Gital Para, Haidarpara, W/No. 40, PS-Bhaktinagar, Dist.- Jalpaiguri along with seized articles (i) 19 (Nineteen) Bottles of 60 UP Country Spirit styled as Himalayan Gold measuring 600 ml each when packed, MRP Rs. 100/- each (ii) 01 (One) Nylon Bag, which used for carrying the seized articles Sl. No- 01.

ASI Biswajit Ghosh of Panitanki TOP under Siliguri PS do hereby lodge a written complaint against the above noted accused person to the effect that today on 27/08/2021 at 18:55 hrs during special raid duty I received secret source information that, one person is selling huge quantity of country spirit at Sevoke Road near Dominus under Panitanki TOP. Accordingly I informed the information to DC Panitanki TOP and as per his direction I along with ASI Ratan Kr Ghosh, C/231 Nagan Ch Barman & CV-1007 Jiten Roy left for PG to work out the information. On arrival at Sevoke Road near Dominus, Siliguri at 19:05 hrs being pointed out by the source, found that one person is proceeding with huge quantity of country spirit containing with a Nylon bag. I intercepted the said accused person with loaded articles in presence of witnesses. During interrogation the accused failed to produce any documents/license in support of the same and stated that he will sale the same to the local public of Haidarpara, Bhaktinagar adjacent area illegally with a view to earn huge money for his lively hood. Accordingly I intercepted the said person with loaded articles in presence of witnesses. On search I recovered (i) 19 (Nineteen) Bottles of 60 UP Country Spirit styled as Himalayan Gold measuring 600 ml each when packed, MRP Rs. 100/- each (ii) 01 (One) Nylon Bag which used for carrying the seized articles Sl. No- 01.


On interrogation he failed to produce any valid documents/license in support of the same and stated that he sale the same to the local people illegally with a view to earn huge money for his lively hood. Accordingly I seized (i) 19 (Nineteen) Bottles of 60 UP Country Spirit styled as Himalayan Gold measuring 600 ml each when packed, MRP Rs. 100/- each (ii) 01 (One) Nylon Bag which used for carrying the seized articles Sl. No- 01 under proper seizure list and labeled the same in presence of witnesses and duly sign by them and also by the accused person and arrested him. The seizure was made between 19:15 hrs to 19:45 hrs and arrested the accused person u/s 41 Cr. P.C after explaining charge against him. Total value of seized articles is Rs. 1900/-

Under the above circumstances I am submitting this written complaint against the above accused person namely Gopi Lama (74) S/O Lt. Kajiman Lama of Gital Para, Haidarpara, W/No. 40, PS-Bhaktinagar, Dist.- Jalpaiguri for starting a specific case under proper section of Law and to arrange for its investigation.
