Sir,

In producing herewith one accused person namely; Ajit Roy (50yrs) S/O Lt. Jitendra Nath Roy of Kawakhali Bazar, PS- Matigara, Dist-Darjeeling along with the following seized articles vize- I) Twenty one (21) sealed Bottles of Himalayan Gold 60 UP country sprit each bottles containing 600 ml. labeled as Himalayan Cndeavour PVT. Ltd Siliguri West Bengal @ Rs. 100/- each (amounting 21x Rs. 100 = Rs. 2100/-) as per seizure list.

I, ASI Subir Sen of Siliguri PS, SPC do here by lodged a written complainant against the above noted person namely Ajit Roy (50yrs) S/O Lt. Jitendra Nath Roy of Kawakhali Bazar, PS- Matigara, Dist-Darjeeling, to the effect that today i.e. on 27.08.2021 hrs at 18:25 hrs received a source information that at Tikiapara Vegetables market, PS- Siliguri above noted accused person was busy to sale ld. Liquor illegally at his vegetables shop situated at Tikiapara Vegetables market under Siliguri PS in order to clandestinely disclose the same. Accordingly the fact is diarized in GD vide Siliguri PS GDE no.1653 dt. 27.08.2021 and informed the fact to I/C Siliguri PS. As per his direction I along with, PSI Rajiv Subba, ASI Siben Sarkar, CV/622 Ramanath Barman and CV/283 Prosenjit Dey left Tikiapara Vegetables market, vide Siliguri PS GDE No.1654 dt.27.08.2021 to verify the veracity of the information. On reached at 18:55hrs there and as identified by source cordoned above noted area where he was selling illegal alcohol. On seeing the Police party the above noted person tried to escape the spot but we managed to apprehend the above noted person and on interrogation, he disclosed his name and identity as noted above. On searching Twenty one (21) sealed Bottles of Himalayan Gold 60 UP country sprit each bottles containing 600 ml. labeled as Himalayan Endeavour PVT. Ltd Siliguri West Bengal @ Rs. 100/- each (amounting 21x Rs. 100 = Rs. 2100/-) which was kept concealed in his shop. On being interrogation he could not produced any valid documents in respect of said liquor. He also stated that he is doing this liquor business since last 08 months approx for wrongful gain. Accordingly I seized the same in presence of witnesses duly signed by them. The seizure and label was made in between 19:25hrs to 20:15hrs. on being asked he stated that he used to sell the same to locality without any valid documents as he has violated the norms of Bengal Excise Act as such I arrested him u/s 41 Cr.P.C. after observing all sorts of rules for selling the said seized articles without any valid license.

I therefore pray before your honor that a specific case may kindly be started against the arrested accused person namely Ajit Roy (50yrs) S/O Lt. Jitendra Nath Roy of Kawakhali Bazar, PS- Matigara, Dist-Darjeeling, under proper section of law and arrange for its investigation.
