I, PSI. Shekhar Adhikary of Matigara PS SPC to the effect that on 27.08.2021 while performing SPL Mobile duty under Matigara PS area found Five persons namely (i) Amit Bhattacharjee (31), S/O Ashit Bhattacharjee of A/57, Basdori, Taliganj, PO - Basdori, PS - Ragenpark, Kolkata, (ii) Manindra Debnath, S/O Lt.
