3. That thereafter the said Debojit Roy called me back on my Facebook messenger video call and WhatsApp video call for several times. When I received his call I was shocked seeing him fully nacked in the video call and then I immediately cut his video call.
4. That again he called me back but I did not receive his call. I knowledge the same to my husband and he advised me to make him know about my marital status

and warn for the same. Thereafter on his next video call I received his call and again I found him in same fully naked condition as mentioned above. I warned him to inform about this criminal act to the department but did not pay any heed to that.

5. That after that my husband recorded all his criminal acts in another mobile and I can show the proof of the same.

6. That all these incidents are creating a bad image of me in my family and society, which could lead to many problems for me in the future. Moreover it is very difficult for women to work with such criminal mindset people in same work field.

Therefore, I request you to urgently look into this matter and start investigating it as soon as possible and oblige me
