Sir,

With due respect, I am producing herewith the arrested accused persons namely (i) Swapan Sarkar (27 yrs) S/O Sanatan @ Sona Sarkar (ii) Sujit Mandal (31 yrs) S/O Netai Mandal both of Baribhasa, PS- NJP, Dist.- Jalpaiguri and (iii) Gopa Sarkar (22 yrs) S/O Sunil Sarkar of Michel Madhu Sudan Colony, PS- NJP, Dist.- Jalpaiguri and the following articles under seizure :-

1. One iron made sharp cutting weapons called as Bhojali and one sharp cutting knife from the possession of accused Swapan Sarkar S/O Sanatan @ Sona Sarkar of Barivasa, PS- NJP, Dist.- Jalpaiguri.
2. One sharp cutting knife and one plastic made charger torch light and from the possession of accused Sujit Mandal S/O Netai Mandal of Baribhasa, PS- NJP, Dist.- Jalpaiguri
3. One iron made Hasua and one iron made sabol from the possession of accused Gopa Sarkar S/O sunil Sarkar of Michel Madhu Sudan Colony, PS- NJP, Dist.- Jalpaiguri.

1. SI Goutam Mallik of NJP PS, Siliguri Police Commissionerate beg to state that on 27.08.21 at 21.45 hrs I received a secret source information that a gang of miscreants come to Back side of Joyguru Mandir, Thakur Nagar under PS- NJP, Dist.- Jalpaiguri with deadly weapons and assembled there and making preparation for committing dacoity at Baribhasa area. Accordingly, I informed the fact to you as well as Asstt Commissioner of Police, East -II, SPC and diarized the fact in General diary vide NJP PS GDE No 1380 dated 27.08.21. As per kind order and direction of my superior officer myself along with ASI Khagen Barman, VP/13 Jamirul Islam, VP/08 Laxman Roy CV/306 Bisawajit Roy and CV/116 Rohit Kr Mahato left for Thakur Nagar Colony to work out the information in hand. I also informed the fact to night RT Van officer ASI Pradip Sarkar and directed him to come to Thakur Nagar to accompany with us. At about 22.05 hrs on 27.07.21 we arrived at near Joyguru Mandir, Thakur Nagar under PS- NJP, Dist.- Jalpaiguri. After a few time ASI Pradip Sarkar along with force came there and accompany with us. At about 22.15 hrs we found that 11/12 persons assembled in a dark place at Back side of Joyguru Mandir and they were whispering in a very low voice. Accordingly we cordoned the place properly and approach towards them very slowly and carefully. But seeing the police party they started to flee away but we the police party managed to apprehended 03 (three) of them. On interrogation the apprehended accused persons disclosed their name and identity as noted above and give different statement in different time and finally they disclosed that they assembled there to commit dacoity at Baribhasa area.
